The following constitutes Amendment No. 6 to the Schedule 13D filed by the undersigned ("Amendment No. 6"). This Amendment No. 6 amends the Schedule 13D as specifically set forth herein.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 is hereby amended and restated as follows:

The Shares purchased by the Reporting Person were purchased with working capital (which may, at any given time, include margin loans made by brokerage firms in the ordinary course of business). The aggregate purchase price of the 1,768,782 Shares beneficially owned by the Reporting Person is approximately \$40,383,081, including brokerage commissions.

Item 5. <u>Interest in Securities of the Issuer</u>.

Items 5(a)-(c) are hereby amended and restated to read as follows:

(a) The aggregate percentage of Shares reported owned by the Reporting Person is based on 8,544,345 Shares outstanding as of November 22, 2023, which is the total number of Shares outstanding as reported in the Issuer's Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on December 6, 2023.

As of date hereof, the Reporting Person beneficially owned 1,768,782 Shares, constituting approximately 20.7% of the outstanding Shares.

(b) The Reporting Person has sole power (i) to vote or direct the vote of, and (ii) to dispose or direct the disposition of, the 1,768,782 Shares held by the Funds.

(c) The transactions in the Shares by the Reporting Person since the filing of Amendment No. 5 to the Schedule 13D are set forth on Schedule A attached hereto and are incorporated herein by reference.
