CITI TRENDS ANNOUNCES FOURTH QUARTER AND FISCAL 2008 SALES

Total sales increased 11.6% to \$488.2 million for the full fiscal year.

Comparable store sales decreased 1.9% in the fourth quarter and were flat for the full year.

SAVANNAH, GA (February 4, 2009) — Citi Trends, Inc. (NASDAQ: CTRN) today reported unaudited sales results for the fourth quarter and full year of fiscal 2008.

Total sales in the 13-week period ended January 31, 2009 increased 8.9% to \$146.6 million compared with \$134.6 million in the 13-week period ended February 2, 2008. Comparable store sales decreased 1.9% in the fourth quarter.

For the year, total sales increased 11.6% to \$488.2 million compared with \$437.5 million in fiscal 2007. Comparable store sales were flat for the full year.

The Company will report complete financial results for its fourth quarter after the market closes on March 25, 2009. Citi Trends will host a conference call on the same day at 5:00 p.m. ET. The online replay will follow shortly after the call and continue until April 1, 2009.

The Company also disclosed its sales reporting policy for future quarters. Commencing with the first quarter of fiscal 2009, the Company will report sales in conjunction with its quarterly earnings release. For future fourth quarters, however, the Company will continue to report sales results on the Wednesday following the quarter end due to the typical longer gap that occurs with fiscal year end reporting and audits.
